

MISSOURI NEA ATTORNEY REFERRAL PROGRAM

All MNEA members and their immediate families* are entitled to two 30-minute consultations† every program year with any attorney participating in our referral program. During those consultations, any type of legal matter except tax matters may be discussed.‡ (However, if the matter is employment related, consult your UniServ Director to see if it would be covered under the ULSP program.)

In addition, MNEA members and their immediate families are entitled to a 30 percent discount with participating attorneys in five core areas of the law – (1) domestic relations, (2) consumer protection, (3) real estate, (4) wills and estates, and (5) traffic violations. The numbers following the attorney's information indicate the areas in which they practice.
